## No-one expects the Spanish Inquisition

Publications were contacted for a Health and Safety Covid Spot check late last week. Inspections have been taking place in Telford's business park and on this occasion it was a virtual 'information gathering' visit rather than an 'inspection'. This involved a phone call and inspectors have a fixed script of questions to go through which takes about 20-30 mins. Bek reported that with the vigorous FSC approach to H&S it was straightforward and we have been told that nothing needed changing or improving. This is good news on several fronts- the first is that we are doing all we can to keep publications staff safe, but in a week when I have written to MPs to convince them that it is possible for FSC to deliver Covid Secure visits, a failed inspection would have severely damaged our reputation. So now is a good time to thank you all for sticking to the rules and to remind staff who may have joined us recently that the Covid Secure Training is a really important part of proving to inspectors that we are compliant, so please take the time to complete the course.

## **MPs Correspondence**

As mentioned above, I have written to all centre MPs again with specific and completely do-able asks to help this sector play its role in helping learners catch up. Those that have always responded quickly and positively even if it's just passing their concerns to ministers did so again but this time we have had proper responses from two that have never engaged much with us before, with one wanting to ask further questions in the house.
