Guidance for the autumn term

England and Wales have both produced detailed guidance for the autumn term which will certainly help with planning for what looks like a busy time. The first minister of Wales also announced yesterday that in bringing forward some of the changes, groups of 30 from organisations such as the Brownies could stay in residential centres from 17th July. Scotland too has set out more information and a direction of travel. Everybody needs to continue to act carefully and remain cautious, and there is a lot of discussion in many sectors around safety for everyone, business continuity and face coverings in particular. FSC has always said that we will follow all the guidelines, it's just when the guidelines leave it up to interpretation that things become more difficult. We are working through all these complex decisions.

Ofqual the Sequel

Following the changes to fieldwork and NEA, Ofqual have published more proposals for the 2022 exams. There are two specific areas of interest for FSC. One is a degree of content optionality in GCSE geography and the other is to continue with last year's rather unimaginative changes to practical science subjects. The geography proposals have an entire annex to themselves where the detailed options for each exam board are set out and you can see them <u>here</u>.

Return of Staff Contracts

Tax Relief for Working from Home

Now's a good time to remind you all about the HMRC tax allowance for working from home. Simply log onto <u>https://www.gov.uk/tax-relief-for-employees/working-at-home</u> (try to avoid searching on google as there are many scam sites). You can claim tax relief on £6 for every week that you have worked from home, so a 20% tax payer would receive £1.20 for each week so over a year it comes to £62.40 and HMRC will pay it as cash straight into your bank account. Sam Dhadwar has road tested the system which he found easy and only took about 5 minutes. He submitted his claim on Sunday, received an email acceptance on Wednesday and the money will be in his account next week. So the next round is on him.
