## Money in the bank

Last week our cash holdings peaked at £5,931,000 just *very* slightly short of the £6m we were hoping to hit. Most of this is from customer deposits for future courses, which reflects the excellent work of the Sales Team to get money into our bank account. It also reflects growing customer confidence too. It's further proof, if any was needed, that the change to our terms and conditions made before Covid has made our financial position much more robust.

#### **An Inspector Calls**

With furlough fraud hitting the headlines, I'm pleased to say that an HRMC inspection into our furlough claim has given us a clean bill of health. The complexities of the furlough schemes (furlough, flexi-furlough and the job retention bonus) were such that individual calculations had to be done for every member of staff every month. Added to this were the frequent changes and extensions to the scheme at short notice and the variation in the % paid changed over time. This created a lot of work for the finance, HR and payroll staff in particular. It was worth it however, as the furlough schemes allowed us to claim a much needed £2.7m. Thank you to all of you who were involved.

## **Biodiversity Training for Housing Associations**

Sanctuary Housing is one of the largest not-for-profit housing associations in the UK. FSC recently delivered some biodiversity training for their staff. It went down very well with the organisation and they particularly liked finding out that environmental policies could be so much broader than just carbon reduction. Since then an opportunity has opened up to talk to the national Charity Sector Procurement Group executive who are on the lookout for interesting speakers. A great opportunity to influence and spread the word.
